Polls will be open from 7 a.m. to 8 p.m. at the Riverdale Park Municipal Center, 5008 Queensbury Road.

All citizens, eighteen years of age or older, who have resided in the Town of Riverdale Park for 45 days or more preceding Monday, May 2, 2005 and who are registered to vote in the Town of Riverdale Park will be entitled to vote.

All residents who wish to qualify to vote in a town election must register on a Prince George's County form. To qualify to vote your registration form must be received at the Board of Elections in Upper Marlboro by Friday, April 1, 2005, 4:30 p.m.

Candidates for office must file Petition and Financial Disclosure Affidavits with the Election Judges at the Town Hall no later than 5 p.m., Thursday, April 7, 2005, in order to have their name on the official ballot. (Financial Disclosure Affidavits and Petition forms are available at the Riverdale Park Town Office.)

Every two years our Town Center Elects a mayor and six members to the Riverdale Park Town Council. With a filing deadline of April 7, 2005 we are aware of at least two candidates for the office of Mayor and at least nine petitions being obtained by candidates for Town Council.

In past elections Riverdale Park has been a hot bed of local political activity with one of the highest percentage turnouts of any municipality in the county. As the elections approach, please familiarize yourself with the candidate's forum which we are beginning to establish at the present time. And most important, take the time to vote in the May 2, 2005 Elections at the Town Hall. We often hear about the precious thing called democracy. Riverdale Park.

Fair Summary of Resolution 2005-OR-02

This charter change would amend the amount of indebtedness outstanding at anytime from 0.4 percent to 4.0 percent of the assessed valuation of all real and personal property as it appears on the County Assessment Records.

Fair Summary of 2005-OR-1

This charter change would amend the tax levy to not exceed \$.75 per \$100 of the assessed valuation of the property.

Fair Summary of 2005-OR-2

The ordinance allows voters, when paper ballots are used in any election, to use a cross (x), a check (✓), a dash (-), or a plus (+) or any mark other than initials in the square opposite the name of a candidate or write-in line when voting.

Kenilfair Shopping Center Planning Study Presentation

The Neighborhood Design Center has mobilized two volunteer Landscape Architects from Rodgers Consulting to complete a planning study for the Kenilfair Shopping Center on Kenilworth Avenue. This team will look at the possibility for façade improvements to the existing businesses and the potential for adding new businesses to the center, since currently the parking lot is underutilized. Ideally these businesses should be at the street edge and should attract potential customers from the burgeoning University of Maryland Research Park on River Road, known as "M Square", destined to be the largest research

park in the State of Maryland.

The presentation will be conducted during the Economic Development Committee Meeting at 7:30 pm on March 29, 2005 in the Council Chamber Riverdale Park Municipal Center.

Public Works Report

Spring Clean-Up Day: Riverdale Park's Spring Clean-up day will be Tuesday, May 31, 2005 for the whole town. Do not put out metals, tires, or items with freon that day. Yard waste and metals will be collected for the A and B sides on Wednesday, June 1, 2005. See tire reminder below.

Tires Reminder: Tires **will not** be picked up free this spring. There is a \$2.50 each (\$2.00 for seniors 60+) charge for tire pickup. Tires are a notorious breeding ground for all types of mosquitoes particularly the Asian Tiger Mosquito. In our efforts to remove and reduce these breeding grounds, your tires need to be removed as soon as possible.

Yard Waste: Yard waste is leaves, weeds, grass cuttings, tree limbs, and anything biodegradable

from your yard. Please **do not mix trash and yard waste** together, as it will not be picked up. Bamboo cannot be collected with yard waste. Please put bamboo out on bulky trash days for pick up. Tree limbs that are up to 6 inches diameter and up to 5 feet long will be picked up. Yard waste is collected on the first collection day of each week for each side.

Keep our Town Beautiful:

Please sweep and remove grass clippings and weeds from the sidewalk and curb/gutter when mowing lawns or trimming weeds near the sidewalk or streets. It is against the Town Code to cause any material of any kind to be scattered, dropped, etc. upon any street, alley, sidewalk, gutter, roadway or public place within the town. Clean gutters allows the easy flow of water and keeps our town beautiful.
