**Mayor's Report**

Good things to report, I submitted to the council my proposed Budget for FY07, copies available in Lobby. Is the finance committee ready for a budget meeting? 4.5 cent tax reduction, that means your taxes will remain the same because property taxes are going up. Livability Grant, we put in to share a street sweeper with Hyattsville, we put in for two and we received one, this cooperation with our neighbors is a good thing. So much trash washes into the rivers by keeping our streets clean this will help keep our rivers clean. The CBDG grant for 48<sup>th</sup> street, the pothole that keeps coming back- despite attempts to get several bidders, we received 2 bids. MUTC meeting Wednesday at 7:30, we plan to see some revised plans. At the last MUTC meeting Potomac Development plans did not comply, Potomac Development stated the guidelines are too dense and that not enough parking is available. We have looked at some successful development areas and one thing that is very apparent is that the municipality has provided parking for areas with dense development. Having looked at our area, Bealle Circle would be a piece of property that could provide some parking, the Town attorney is looking into this option, we do not have a firm report back as of yet. I would also like to tie this in with the Eakin Young and Taub, we are trying to come up with a park or green space that would benefit Hyattsville and Riverdale Park, Bealle Circle is not the best-suited area for a park with its

proximity to 410. I would like to see us turn Bealle Circle into parking and look for more suitable area for a park.

# Ingraham paper street Waiver/ Variance for Road to remain gravel  
Mayor gave background and G&C quote of \$ 22,000.00. Developers gave background 5004 Ingraham Street. Mayor stated Ingraham is a paper street with some limited gravel improvement. Town policy is when streets are done they are done to county standard, developers would like a waiver as this is the only build able lot on the street. Developers have a quote for \$ 10,000.00. Developers want to use the existing gravel as the street. Discussion on leaving the roadway as gravel and paving the driveway. Mayor asked for staff input- Police Department has no problem- waiting for Fire Departments written report. CM Kiernan asked about the legality of a gravel street. Developer spoke with County and was told that this particular street standard would be left up to the Town of Riverdale Park. CM Kiernan expressed concern about providing services and the precedence this would set for the 11 lots across the street. CM Oppenheim thought it was fine, CM Sargusingh stated the drainage ditch was a concern but not really the street or driveway. CM Kiernan is concerned with the legality and future problems
