#### Town Awarded \$100,000 **Community Development Block Grant**

County Executive Jack Johnson has announced that the Prince George's County Council has approved Riverdale Park's funding application for \$100,000 for 54<sup>th</sup> Avenue street improvements. This funding award was included in the 2006-2007 Housing and Community Development Annual Action Plan, which has been submitted to the U.S. Department of Housing and Urban Development (HUD). The improvements will be in Wards 4, 5, and 6.

This marks the 28<sup>th</sup> consecutive year the Town has been awarded a CDBG grant. To date, \$3 million has been received for a variety of infrastructure improvements throughout the Town for such items as streetscape improvements to the Town Center MARC train station, Queensbury Road, Baltimore Avenue, Riverdale Road from Kenilworth Avenue to Lafayette Avenue, as well as various streets, sidewalks, curb and gutter, and handicap ramps throughout our community. HUD usually releases the sub-recipient grants in early fall and the project must be completed by June 30, 2007.

#### Code Corner The Tiger Mosquito and West Nile Virus By Colleen Ferguson

The Maryland Department of Agriculture (MDA) recently trapped Asian Tiger Mosquitoes that tested positive for West Nile Virus in two areas of Riverdale Park. Test results on Asian Tiger Mosquitoes trapped in the 4600 block of Tuckerman, and the 5500 block of Taylor Road were positive for the West Nile Virus. Because of this, MDA is stepping up mosquito spraying from one evening a week (Tuesday) to three evenings a week (Tuesday, Wednesday, and Thursday). Riverdale Park Code Enforcement is conducting yard inspections and asking residents to inspect their yards for mosquito larvae.

The Asian tiger mosquito is a very aggressive daybiting mosquito which has become a serious pest to humans and animals. It is a black mosquito with white stripes on the legs and a white stripe down the middle of its head and back. The mosquito lays its eggs in containers or holes in trees and is closely tied to human habitation.

Any container in your yard which will hold even a small amount of water for a week or more can breed the Tiger Mosquito. Possible water holding containers include: tires; kiddie pools not in use; buckets, barrels or cans; wheelbarrows, canoes, or boats; tarps where water can pool; flower pots or saucers under pots; or containers holding water that remains undisturbed for a week or longer.

You can control this pest by emptying and storing, or rinsing containers out weekly. Don't forget your gutters—standing water in gutters is an excellent breeding ground for this mosquito. If you have Asian tiger mosquitoes, you can spray with sprays that contain Resmethrin, Permethrin, or Pyrethrin. Remember, only the home owner can control these mosquitoes! Please call Riverdale Park Code Enforcement if you have questions or want assistance in inspecting your yard.

#### Tigre Asiático

El Departamento de Agricultura de Maryland recientemente atrapo varios zancudos tigre asiáticos que resultaron positivos con el Virus del Nilo Occidental en dos áreas de Riverdale Park. Los resultados de los zancudos que fueron atrapados en las cuadras de 4600 Tuckerman Street y 5500 Taylor Road fueron positivos con el Virus del Nilo Occidental. Por esto El Departamento de Agricultura de Maryland en vez de rociar pesticida solamente una vez a la semana (martes), ahora lo harán tres noches por semana (martes, miércoles, y jueves). El Código Legal de Riverdale Park esta conduciendo inspecciones en los patios y le piden a los residentes que inspeccionen sus un patios para encontrar larvas de zancudos.

El zancudo tigre asiático es muy agresivo y pica durante el día, lo cual se ha convertido una peste para los seres humano y los animales. Es zancudo negro con rayas blancas en las patas y cuerpo. El zancudo pone sus huevos en envases o agujeros en árboles y en lugares habituados por humanos.

Cualquier recipiente en su patio que estanque aunque sea una pequeña cantidad de agua por una semana o mas puede criar zancudos. Lugares donde posiblemente se estanque agua son: llantas, piscinas de niños que no se estén utilizando, cubetas, barriles o latas; carretillas, canoas o botes, impermeables en donde se pueda acumular agua, macetas, recipientes que mantengan agua por mas de una semana sin mover.

Usted puede ayudar a combatir esta peste vaciando y guardando, o desaguando recipientes semanalmente. Vacié el agua estancada de tormentas y canales porque es un excelente criadero de zancudos. Si usted tiene zancudos tigre asiático usted puede rociar con líquidos que contengan Resmethrin, Permethrin, o Pyrethrin. Recuérdese que solo los propietarios y residentes pueden combatir estos zancudos. Por favor llame al Código Legal de Riverdale Park si tiene preguntas o quiere asistencia para inspeccionar su patio.

## **Public Works Notices**

#### **Holiday Pick Up**

Monday, September 4, 2006, Public Works will be closed. Regular trash and yard waste pick up for Area A will be on Tuesday, September 5, 2006. Regular trash and yard waste pick up for Area B will be on Wednesday, September 6, 2006.

#### **Town Street Trees**

Trees that grow between the street and sidewalk are street trees which belong to the state of Maryland. It is the town's responsibility to keep these trees pruned. It **is against the law for residents to cut, prune, or remove these trees.** If a tree needs pruning please call Public Works to let us know (301-864-1803). If there are branches rubbing against or pushing on electric lines, please call Pepco to have those branches pruned (202-833-7500).

#### **Residents Help Wanted**

If a resident finds a problem in town such as a pot hole or town owned street light out, please call Public Works at 301-864-1803 to see if we are aware of the problem yet. It is difficult for Public Works to fix something that we are not aware of.

#### **Contacting Public Works During Emergencies**

In extreme emergencies (i.e., snow storms, hurricanes, etc.), resident calls for Public Works need to be routed to the Police Department (301-927-4343), who will contact us. Often Public Works staff is not available to answer the phones during such emergencies; but the Police Department has radio communication with Public Works.

#### Lights Out

It is important that residents call and report that their electricity is out. This helps Pepco to better understand a widespread outage, as well as where or what the problem may be. Pepco now has an automated system designed to speed the restoration by automatically feeding your outage information into the computer system so crews can be assigned. It takes and analyses the information more quickly than a person can immediately following a storm, and handles up to 100,000 calls an hour, which reduces busy signals and hold times. The system works by matching your phone number to your account. If you report your outage from another number you will be asked to provide additional information such as your address or account number. If power has been restored in your neighborhood but not to your home, you should call 1-877-PEPCO-62 and report the outage again.

There could be a separate problem in the neighborhood or even at your individual service connection.

## Economic Development Update

#### **Revitalizing the Town Center and Rt. 1**

The surveys are in! Thanks again to everyone who filled out a survey and a special thanks to the Farmers' Market for emailing out details to their email list. While similar surveys have been done in the past, this one is unique in its focus on surveying residents of the Town and the surrounding community. The fact that more than half of the survey respondents were from outside the Town shows the potential market that exists for new businesses. Convincing business and financers that empty storefronts could yield success is a hurdle that can only be overcome by having good data.

The next phase for our consultant, Kennedy Smith, is to conduct a market analysis for our community. This market analysis will give us the evidence we need to recruit specific businesses. We may want a specialty grocery store, a dry cleaner, a bakery, and a café, but will the market sustain these businesses especially as other nearby communities recruit their own restaurants/ businesses? In addition to collecting and analyzing a lot of data, Kennedy will also be interviewing a handful of residents and business owners, and will be conducting focus groups. The market analysis will be completed by December 2006 and will be one of the key tools to help recruit new businesses and to assist existing businesses.

#### **Development Projects**

After hearing comments from Town Council, the Patriot Group decided to withdraw its proposal for a 144 condominium building. The proposed project would have been located on Lafayette Street and would have spanned the areas currently housing the credit union, Dumm's corner market and sub shop, and the adjacent boarding house and parking lot. The Spiropolous' are still interested in redeveloping their property and expanding the size of their stores.

Potomac Development Corporation presented a revised proposal at the August Legislative Session for the intersection of Rt. 1 and 410, and asked for comments from Council. The new proposal includes a 2-story building with 8,050 square feet, a 5-lane drive thru, and 43 parking spaces. The entrance to the bank would be located on the side, while the entrance to the second floor would face Baltimore Avenue. If you have comments regarding this proposal, please direct them to your Ward representative. This project is just starting its formal review process with planning. This project received an unfavorable recommendation from M-UTC because it did not meet the intent of the M-UTC guidelines. The proposal has been revised since then to include a second floor. The following site plan depicts the new proposal.



EYA presented preliminary information to the M-UTC committee on their proposal for the eastside of Rt.1. A portion of the project—approximately 32 townhomes—will be in the Town of Riverdale Park.

The final site plan review for the NOAA Center for Weather and Climate Prediction will occur in October at the County Planning Board. Information on all of these projects is available at Town Hall.

People like Lou King, who is helping the Town improve our cable broadcasts of town meetings; Marita Novicky and David Lingua who pulled together a thank you celebration for Doris Pullman's decades of service to the town; David Lingua, for taking over the leadership of the Recreation Board; Kristin Liu, for organizing Riverdale Park's upcoming Gorgeous Prince George's event; and the entire Farmers' Market Committee for their work in creating a success story in our Town Center deserve all of our thanks. Volunteers are an essential part of a strong community and if you are interested in becoming more involved in Town, please check out the Community Circle page in the *Town Crier*.

#### Safe, Clean and Beautiful

Over the past few months, I have been working with Town staff to increase coordination among departments to ensure a Safe, Clean, and Beautiful Riverdale Park. For instance, code enforcement officers are meeting more often with the Police Department and helping the Department train officers to respond to code concerns. While we still have a ways to go, we're heading in the right direction. In addition, the Town is completing a new Code Enforcement Handbook to give residents more information on the regulations that govern our small community and thanks to a joint Livable Communities Grant with Hyattsville the Town will soon have a street sweeper to more regularly clean our streets. There is also an opportunity for all of us to volunteer for Gorgeous Prince George's Day on October 14th. This year volunteers will be removing invasive species at the park on Queensbury between the river and school and planting native trees and shrubs.

#### **Economic Development**

Kennedy Smith, our economic development consultant, has completed her initial assessment of our town and is starting to conduct our market analysis. The market analysis will: measure the retail "buying power" of Riverdale Park residents and visitors and identify opportunities for new businesses and new retail product lines with market viability. This analysis will be essential for the recruitment of new businesses and will be helpful for our existing businesses. Some of the things that the consultant noted in her initial assessment are the following:

- **Opportunities**: The Town has a variety of assets including the MARC train station and Rt.1; proximity to Riversdale, UMD, and the new M-square project; a thriving farmers' market; and enthusiastic citizens who care for the Town Center and are concerned about its future.
- **Challenges:** The design of two key parcels—intersection of Rt.1/410 and development of Dumm's Corner—will play a key role in influencing future development; increasing competition from nearby communities; and long-vacant storefronts.

Have an enjoyable September and don't forget to mark your calendars, Riverdale Park Day is coming up on October 7, 2006 from 12:00 p.m. -5:00 p.m. The Town of Riverdale Park will be providing free music as well as free activities for kids.

## Ward Reports

## Ward 1

#### **Roads Resurfaced**

Resurfacing of the west end of Queensbury Road (from Route 1 toward Hyattsville) and 43rd Street is completed. It's a big improvement, despite the fact that a paving crew dripped asphalt on the new sidewalks and streets in the 4300 and 4400 blocks of Queensbury. Hopefully, the mess will be gone by the time you read this. Roadwork on 48th Avenue near the fire station also was completed recently. For decades, that street has taken a beating from the heavy bus and fire engine traffic leaving it with big potholes. This time, the repair went deeper to rebuild an inadequate roadbed, and the fix should last a long time. Lots of resurfacing is planned for the next year; the FY 2007 budget includes a \$3 million bond to pay for street and sidewalk repairs.

#### **Town Clock**

The Town Center's Anniversary Clock continues to run adrift of the time and to chime past 10 p.m. We are looking at ways to fix this beautiful old clock—some basic maintenance, fix the battery backup and a possible upgrade to automatically set the time to the GPS standard. #### **Patriot Group Walks**

At the July Council meeting (7/3/06), the Patriot Group asked council members for opinions on the 5story condominium project at Dumm's Corner.

The exchange was polite but firm. Several council members said the buildings were unacceptable because of their height and other areas of M-UTC nonconformance and because of the possibility that the project could set a worrisome precedent.

At the session's end, a Patriot spokesman said, "I don't think this project is going to go forward. We did enjoy working with you. We would certainly look forward to working with you on another project."

#### Wachovia Bank Moves Ahead

At the August Council meeting (8/7/06), Joe Caputo presented the latest proposal for the Wachovia Bank at the corner of Route 1 and East–West Highway. The company is offering to allow municipal parking outside of banking hours, to donate the corner lot to the town, and to add a second story that would have an entrance on Route 1. The developer also promised to investigate still more features requested by the council—a walkup ATM and a canopy over the front entrance. Council members' reactions generally were positive. Although no official vote or approval was given, it looks like the Wachovia Bank project is going forward.
